



### About The Royal Star & Garter Homes

The Royal Star & Garter Homes is a charity dedicated to the care of the military family. We provide pioneering care to disabled ex-Servicemen and women, and their partners, in our friendly, modern and comfortable Homes.

In 2004, the Charity made the bold decision to move from its iconic Richmond Home and to create three new modern Homes across the country so that we could continue to offer excellence in care. By April 2019 we will complete this journey, with our third Royal Star & Garter Home opening in High Wycombe.

Our Surbiton Home received top ratings by Dementia Care Matters, indicating that the Home is demonstrating exceptional person-centred dementia care. Our care has also been recognised in the National Dementia Care Awards 2016, and in 2018 our Activities & Volunteers Manager, won the Care Activities Coordinator / Facilitator award in the National Care Awards.

We have been always been at the forefront of social care for disabled veterans with many of our innovative approaches now widely adopted within mainstream services. 40,000 veterans will be living with dementia in 2020, and the need for our high quality care increases every year.

Our new strategy reaffirms our promise to deliver excellent nursing and dementia care, but also commits The Royal Star & Garter Homes to an exciting programme of innovation by developing new models of care and to raise the standards of care for all veterans.

Over the next five years we will invest significant sums to at least double the number of veterans we support, and also offer greater choice and flexibility to our beneficiaries. By openly sharing our own best practice, being active participants in programmes of academic research and fully engaging in national initiatives, the Charity will continue to play a leading role in developing improvements for all disabled veterans.



### About this opportunity

This is a critical role for us, the Home at Surbiton has 63 residents and a staff team of 120 all of whom care deeply about their work and the people they support. The Home is a place of love and laughter and this is obvious from the moment you step through the doors. Residents don't join us to sit in a circle, watching daytime television. They come to live life to the full, to make friends, try new activities and adventures and to relax in our spacious and well-designed accommodation. We are seeking someone who shares our desire to provide the very best for people who have served their country.

We want a registered nurse who has experience leading a successful team and who wouldn't have it any other way than to be hands on and who demonstrates a can-do attitude. We want someone with a clear and constructive communication style, who can build teams and who has a confident and fair approach to their leadership.

We offer a competitive salary and pension scheme, as well as 25 days annual leave. We are also open to discussing other benefits including a relocation package so that geography does not become a barrier to you applying.

You will be based at the Surbiton Home which is close to Kingston upon Thames, Surrey, but will be required to occasionally visit our other Homes in Solihull and High Wycombe to share best practice with your peers. Reporting to the Director of Care you will:

- Lead the team to achieve an 'outstanding' inspection report
- Lead, develop and manage a team of experienced staff
- Oversee the quality of care provided to our residents
- Be responsible for all issues relating to safeguarding
- Have a flexible attitude towards your working hours to meet the needs of residents and staff
- Be responsible for a staff team of 120 with direct line management of 7.

- Have senior management experience ideally in a care setting
- Have significant experience of successful people

- Have an affinity with the Military Service community
- Able to satisfy the requirements for DBS and CQC registration
- Be able to demonstrate up to date clinical CPD


- We provide a warm and loving atmosphere that encourages positive relationships
